### **Options Expiry**

The Company advises that the shortfall of the 31 December 2012 listed option ("JKAO") is 65,253,913 Options. The Directors note that they will place the underwritten shortfall of 43,916,476 in accordance with the Option Underwriting Agreement with DJ Carmichael Pty Ltd as announced on ASX on 21 November 2012.

The converted options and the underwritten shortfall will raise \$10 million (before costs) for the Company which combined with current cash reserves will see the Company fully funded for its current 2013 work program.
